Judging will be of artwork only.

WHERE: Bring art entry and this contest form to the **Exhibition of Fine Art**, Turf Club, Fourth Floor, East Grandstand, between 11:00am and 2:00pm on day of contest. Your entry and this contest form will admit you into the Fair FREE between those hours. Contest judging begins at 2:15pm. **Exhibitors must personally deliver their entry.** No pre-registration is required.
